For selling physical prints made from licensed digital files

Sell physical prints for the lifetime of the license. Keep every source file private. No renewal fee.

1. License grant

When a customer lawfully purchases the commercial license option for a product, The Master Forge grants that customer or named business a lifetime, nonexclusive, nontransferable license to manufacture and sell physical prints made from the licensed files, subject to every term in this document. The license requires no recurring fee.

2. What you may do

- Print and sell finished physical models made from the licensed files.
- Sell physical prints in painted or unpainted form through your own website, online marketplaces, social channels, conventions, retail locations, and direct customer orders.
- Resize, support, slice, repair, and make practical print preparation changes needed for production.
- Photograph your own physical prints and use those photographs to market the licensed physical products.
- Use employees or contracted production partners when access is limited to licensed production and the source files remain confidential.
- Continue selling licensed physical prints for the lifetime of the license, provided these terms remain satisfied.

3. Commercial conditions

- The license covers one purchaser or one legal business entity named on the order.
- The license applies only to the specific product identified on the purchase receipt.
- Only physical prints may be sold. Digital files and digital derivatives may never be sold or distributed.
- A marketplace listing must clearly describe the item as a physical print and must not imply that digital files are included.

- Where a platform requests a designer or creator name, identify The Master Forge as the original designer.
- The license holder remains responsible for the conduct of employees, contractors, and production partners who access the files.

4. What you may not do

- Share, upload, email, transfer, distribute, sublicense, or resell the source files or any modified digital version.
- Sell access to the files through a membership, subscription, shared drive, repository, marketplace, or private group.
- Sell remixes, conversions, supports, slices, or altered digital versions of the files.
- Transfer this license to another person, branch, franchise, seller account, or business entity without written approval.
- Use The Master Forge logo, trademarks, product renders, or store presentation in a way that suggests official affiliation or endorsement.
- Register the design, sculpt, product name, or related artwork as your own intellectual property.
- Use the files, renders, or related artwork to train an artificial intelligence model or build a commercial dataset.

5. Quality and customer responsibility

The commercial seller is responsible for print quality, product safety, packaging, customer service, taxes, marketplace compliance, and every statement made in its listings. The seller must not describe a physical print as manufactured, inspected, or fulfilled by The Master Forge unless The Master Forge has confirmed that arrangement in writing.

6. Scope and growth

There is no unit limit and no revenue cap for physical prints sold under this license. Additional products require their own commercial license. A business with separate legal entities or independently operated seller accounts requires a license for each entity unless The Master Forge approves a broader arrangement in writing.

Ownership and intellectual property

The Master Forge retains all ownership, copyright, trademark, and other intellectual property rights in the digital files, product artwork, renders, branding, and documentation. This license grants specific use rights only. It does not transfer ownership of any intellectual property.

File security and responsible access

- Keep the source files private and use reasonable measures to prevent unauthorized access.
- Store working files and backup copies only on devices or services controlled by the license holder.
- Employees and contractors may access the files only when access is necessary for licensed production and they are bound to confidentiality.
- A production partner must delete all working copies when the production task is complete.

Updates, delivery, and support

The purchase includes access to the files and documentation supplied with the product at the time of purchase. The Master Forge may provide corrections, updated files, or additional guidance at its discretion. Support is provided through the contact channel shown on The Master Forge store. Access to a specific third party platform or storage service is not guaranteed indefinitely, so the license holder should maintain a secure backup.

Refunds, payment disputes, and termination

If a purchase is refunded, reversed, charged back, or found to be unauthorized, this license ends immediately and every copy of the digital files must be deleted. The license also ends upon a material breach of these terms. Ending the license does not remove any payment obligation or legal remedy that arose before termination.

Warranty and limitation of liability

Digital files are supplied as available. Printer calibration, material choice, slicing settings, supports, machine condition, and user technique can affect results. To the fullest extent permitted by law, The Master Forge is not responsible for indirect, incidental, special, or consequential loss arising from use of the files. Any direct liability is limited to the amount paid for the licensed product.

General terms

- This license is the complete agreement for use of the licensed files unless a separate written agreement signed by The Master Forge applies.
- If one provision is found unenforceable, the remaining provisions continue in effect.
- A failure to enforce a provision once does not waive the right to enforce it later.
- The laws that apply at the principal place of business of The Master Forge govern this license, subject to any mandatory consumer law.
- Questions about permissions outside this license must be approved in writing by The Master Forge before use begins.

Acceptance

By purchasing the commercial option, downloading, accessing, producing from, or using the licensed files, the purchaser or named business confirms that these terms have been read, understood, and accepted.
